

## ATTACHMENT II

MEMORANDUM: THE FIRST CONFERENCE OF THE SPANISH ASSOCIATION OF ANGLO-AMERICAN STUDIES, HELD IN GRANADA FROM 15-17 DECEMBER, 1977

All the participants arrived to Granada the evening of Wednesday, 14 December, and were lodged in accommodations reserved by the Secretariat at the University of Granada, headed by Professor Rafael Fente, the Chairman of the Department of English.

Before and during the initial lecture and subsequent panel discussions the following day, memberships in the Spanish Association of Anglo-American Studies were registered by Patricia Zahniser of the Fulbright Commission. This table in the Secretariat remained open from 9:00 A.M. of the first day of the Conference until after the closing General Meeting at 2:30 P.M., 17 December. In that period, 128 memberships were finalized, personal and professional data having been filed for each member, and membership fees having been collected.

Two general meetings of the Association were held. The first consisted of both a review of the work of the provisional Executive Board (Patricia Shaw, Javier Coy and Joaquín Oltra) during the past year, and a series of discussions in order to establish the electoral norms for the new Executive Board to take place the following meeting. Professor Harry Allen spoke at the beginning of the first meeting to outline the work of the European Association of American Studies, Dra. Patricia Shaw informed those present of the work to date of the provisional Board in previous meetings, Javier Coy gave a summary of the budget of the Association, and Joaquín Oltra reviewed the Association's legal statutes. Modifications for various points in these statutes were discussed, and it was suggested that the new board consider these recommendations.

Mr. Ramón Bela undertook the direction of the second part of the meeting dealing with election procedures, drawing from his experience in other professional organizations. He pointed out that the main problem with these procedures was the distribution of executive positions on the board. Would the Association decide to establish a minimum number of signatures for each candidate presented? Which, if any, qualifications would be set for these candidates? Which system of voting would be used to avoid a split among the members? With these considerations in mind, the members voted that, due to the size of the Association at present, no minimum number of signatures would need to accompany a candidate's name; that prior to the election, each candidate would present his ideas regarding the Association to the members; and that in order to encourage unity among the members, that from a general list of candidates a separate round of votes be held for each executive officer. In addition, and upon Mr. Bela's suggestion, it was decided that two of the five new executive officers be taken from the provisional board to assure continuity. Finally, the meeting was adjourned until 11:30 A.M. Saturday, and the period was declared open for the presentation of candidates.

Between sessions, Mr. Bela held meetings with several of the candidates proposed, some of whom were later elected--in particular the President-elect, Dr. Javier Coy--in order to orient them in this regard and supply them with additional information to prepare the second meeting.

When the second general meeting was opened on Saturday morning, the list of candidates was read to the members, as follows: Mr. Francisco Martínez López, José Antonio Martínez López, Leopoldo Mateo Alvaro, Julio-César Santoyo, Manuel Angel Conejero, Antonio Garnica Silva, Francisco García Tortosa, Joaquín Oltra and Javier Coy. Each one presented a brief outline of his personal objectives for the new Association. Envelopes were then distributed to all registered members containing five blanks for the election of each of the executive positions: President, Secretary, Treasurer, First and Second Vocales. The results of the election, unanimously approved by the members, were recorded as follow:

President	: Dr. Javier Coy
Secretary	: Dr. Joaquín Oltra
Treasurer	: Dr. Francisco García Tortosa
1st Vocal	: Dr. Francisco Martínez López
2nd Vocal	: Dr. Antonio Garnica Silva

Before the meeting was adjourned, it was mentioned that the next Conference will be held in Valencia in December of 1978, and suggestions for the central Conference theme were requested.

The Fulbright Commission in Madrid wishes to commend the entire Secretariat at the University of Granada, and in particular Dr. Rafael Fente, and the provisional Executive Board of the Spanish Association of Anglo-American Studies, for their excellent organization of this First Conference of the Association. Comments received regarding the Conference have been unanimous in their declaration of the high quality of the conferences themselves and the more specific panel discussions in which the members participated with enthusiasm.
